REGULAR SEASON: 55-minute matches will be played on Tuesday nights beginning at 6:00 p.m. All teams will play 2 matches (6 games) per night, as light permits.

Teams not ready for play at the scheduled time will forfeit the game. The postponement of play will be determined by the two opposing team captains and the referee.

INCLEMENT WEATHER: All teams must report to the field regardless of weather conditions or forecast. Rescheduled games will be based on referee availability. Check with your team captain for rescheduled rain dates. Make-up days will be announced during the season.

TEAM ROSTER:

- Due by April 25, 2017. Changes will be accepted until June 6, 2017.
- Each team must have at least six (6) players on its roster.
- A team must have three (3) players present to begin a match, with at least one (1) female player on the court during play. Possible male / female combinations for play: 1 female, 1, 2 or 3 males; 2 females, 1, 2 or 3 males; 3 females, 0, 1, 2 or 3 males; 4 females, 0, 1 or 2 males; 5 females, 0 or 1 males; 6 females, 0 males.
- All players must be employees of a company at Innsbrook or a spouse of such employees, or a resident of one of Innsbrook's neighborhoods. "Significant Other" is considered in the same category as a spouse. Exception to the employee rule is applied to former employees who have played a previous season and still want to play on team and if a team is accepted into the league to make the number of teams even. The Volleyball League Coordinator must approve all exceptions.
- Roster changes/additions are permitted until June 9, 2017. After that date, no changes will be allowed unless approved by the Volleyball League Committee.
- Eligibility for tournament play - those persons on the roster by June 6, 2017.
- Any game played using an ineligible player is subject to forfeit.
- Questions concerning rosters will be handled by the Volleyball League Committee.

TOURNAMENT:

Tournament format will be pool play with teams seeded according to their regular season finish. The top 4 move on to the semi-finals, and the winners move on to the final match. The tournament is tentatively scheduled for Saturday, July 8, 2017, depending on the number of weather related make-up dates. Recognition for the Summer Season and Tournament will be awarded at the end of the day on Saturday.

RULES:

REFEREES:

Please cooperate with all referees as they are considered to be the experts on the field. Teams are expected to know the rules. Only the team captain may discuss questionable calls or ask for a clarification on a call. Teams and team members may be expelled from the game, the entire match and the league at the discretion of the referee.

STANDINGS:

Game results and standings are emailed to the team representatives the day after play.
